Privacy Policy

This Privacy Policy applies to MedImpact Healthcare Systems, Inc. and its affiliated entities including, but not limited to, MedImpact Direct, LLC, and 340B Holdings, LLC, each a wholly owned subsidiary (hereinafter referred to as "We," "Our," or "MedImpact"). By using Our Website, you are agreeing to this policy. We may update and change this policy from time to time without notice to you. You are responsible for reviewing the Terms of Use and the Privacy Policy on a regular basis to make sure you are still in agreement to comply with them. By using or accessing this Website ("Website") and services after changes have been made to the Website and services, or the Terms of Use or Privacy Policy, you are agreeing to accept those changes. MedImpact respects the privacy of your information and We provide this explanation about Our online information practices as a show of Our commitment to protect your privacy. This Privacy Policy is hereby incorporated by reference into the User Agreement.
